**NEW RESERVED TEE TIME REGISTRANTS**

- **PRIOR TO April 12, 2025:** Payment of \$400 for the foursome (\$100 / person) is due upon registering. **Each week you will pay your fee of \$65.**
- Replay rates are \$32.50 for up to 18 holes including cart. Please sign the contract and return as soon as possible. All tee times will be reserved on a first come, first served basis.

**PRIVILEGES & RESPONSIBILITIES**

As a RESERVED TEE TIME holder your group guarantees payment of a full foursome green fee / cart each week during the 25-week period, and agrees to the following conditions.

- Each group must designate a contact person who is noted as "Captain."
- The "Captain" is responsible for the foursome and any / all guaranteed fees for the week.
- Show-up for your scheduled time.
- Check-in thirty (30) minutes before your tee time.
- Players must have their own set of clubs, or may rent clubs from the pro shop.
- Only two riders and two bags per golf cart.

- Players are to maintain the pace of play guidelines established by the club. If you tee off between the hours of:
  - 6:00 am – 7:00 am > 4:00 -4:10 hours
  - 7:00 am – 8:00 am > 4:10 -4:20 hours
  - 8:00 am – 9:00 am > 4:20 -4:30 hours
- Players and guests are required to adhere to the facility dress code.
- No personal coolers, food or beverage are allowed to be brought on to the course.
- Respect other players, the golf course and the staff at Lake Bluff Golf Club.
- No golf carts are allowed to travel through the surrounding areas.

Any disregard for club rules will lead to forfeiture of RESERVED TEE TIME. This contract is in effect for the 2025 golf season only.

#### **PROPER CONDUCT**

RESERVED TEE TIME holder / group is responsible for proper conduct, attire, use and care of the golf course, facilities, equipment and golf carts. The RESERVED TEE TIME holder group is liable for any damage to person, the course/club, equipment, golf carts, clubhouse facilities and surrounding areas.

#### **FOOD & BEVERAGE**

All food and beverage consumed on site must be purchased from the course/club. The course/club does not permit the service of alcoholic beverages to anyone who is under the age of 21, or who the course/club (in its sole discretion) determines may be intoxicated. Only Lake Bluff Golf Club staff may prepare and serve food or alcoholic or non-alcoholic beverages. These rules are necessitated by our liquor license and food permit.

#### **INCLEMENT WEATHER**

Frost, fog or inclement weather may cause delay of tee times. If playing conditions require cancellation of the RESERVED TEE TIME by the course/club, the tee time will be rescheduled by the staff at the course based on the first available weather date that is convenient. Our liberal rain check policy will be in effect as determined by management. Play 9-holes, get 9-hole rain check; play less than 9-holes, get 18-hole rain check.

#### **GOLFING PROGRAM WAIVER & RELEASE**

The staff of Lake Bluff Golf Club and GolfVisions is committed to conducting its recreation programs and activities in a safe manner and holds the safety of participants in high regard. The staff of Lake Bluff Golf Club and Golf Visions continually strive to reduce such risks and insists that all participants follow safety rules and instructions that are designed to protect the participants' safety. However, participants registering for this program must recognize that there is an inherent risk of injury when choosing to participate in recreational programs/activities.

You are solely responsible for determining if you are physically fit and/or adequately skilled for the activities contemplated by this agreement. It is always advisable, especially if the participant is pregnant, disabled in any way or recently suffered an illness, injury or impairment, to consult a physician before undertaking any physical activity.

**WARNING OF RISK & IMPORTANT INFORMATION**

Golfing is an activity intended to challenge and engage the physical, mental and emotional resources of each participant. However, despite careful and proper preparation, instruction, medical advice, conditioning and equipment, there is still a risk of serious injury. Understandably, all hazards and dangers cannot be foreseen. Risks attendant to golfing include poor conditioning or technique; being struck by a golf ball or club; being struck by lightning; slipping on wet surfaces; slip and falls associated with the choice of spikes; accidents with golf carts; inconsiderate play; horseplay; defects in course design; tripping over sprinkler heads, and ruts/holes/depressions in the grass. In this regard, it must be recognized that it is impossible for the staff of Lake Bluff Golf Club and GolfVisions to guarantee absolute safety.

You should always stand away from and behind a player making a shot and be aware of flight patterns of balls being hit by other players when you are around the greens and alongside the fairways. You should watch where you are walking (i.e., uneven terrain, sprinkler heads, surface imperfections, etc.). When playing a shot from a wrong fairway, ensure that the players playing that fairway are aware of your presence. During a thunderstorm, do not ride in golf carts or stay outdoors; seek shelter in buildings, vehicles, or other locations that offer protection (avoid open fields, water areas, wire fences, overhead wires, isolated trees, and hilltops). Drive carefully and slowly in golf carts.

**WAIVER OF ALL CLAIMS AND ASSUMPTION OF RISK**

After reading the above, I am aware of risks associated with playing and participating in this program. By signing below I am expressly assuming the risk, legal liability and waiving and releasing all claims for injuries, damages or loss which I might sustain as a result of participating in any and all activities connected with and associated with this program /activity (including transportation services and vehicle operations, when provided).

I recognize and acknowledge that there are certain risks of physical injury to participants in this program/activity, and I voluntarily agree to assume the full risk of any and all injuries, damages or loss, regardless of severity, that my minor child/ward or I may sustain as a result of said participation. I further agree to waive and relinquish all claims I or my minor child/ward may have (or accrue to me or my child/ward) as a result of participating in this program/activity against the staff of Lake Bluff Golf Club and GolfVisions, including its officials, agents, volunteers and employees.

***In conjunction with the above, I have read and fully understand the important information, warning of risk, assumption of risk and waiver and release of all claims. If registering via fax, my facsimile signature shall substitute for and have the same legal effect as an original form signature.***
